Long-Term Option

A bonded warehouse is a solution for long-term storage and deferring duties until your goods leave the warehouse. You may want to store your goods until there is an increase in demand for the goods or wait for the best moment to make a deal.

You do not need to arrange import clearance for all your goods at once. This is especially convenient for slow-moving items such as spare parts or high-value goods. Goods can be stored for 3 years (if a product has a limited shelf life, it must leave the warehouse 180 days before its due date), there is no rush on paperwork, payment, or inspection.

Re-sale of returns (goods that have been refused or that could not be delivered), with the Customs declaration being canceled after the initial sale (the goods go back into bond after a period of 90 days).

Our bonded warehouse facilities provide government supervision and security for goods before payment of duty.

Goods processing

- With the permission of the customs authority, you can perform several operations with the goods (sorting, packaging, etc.).
- You can carry out operations without customs permission in order to ensure the safety of the goods, without changing their condition, for example, drying and airing.
- (*) Certain goods like precious metals, edged weapons, and firearms, military equipment, explosives, etc. are not allowed for this procedure.
